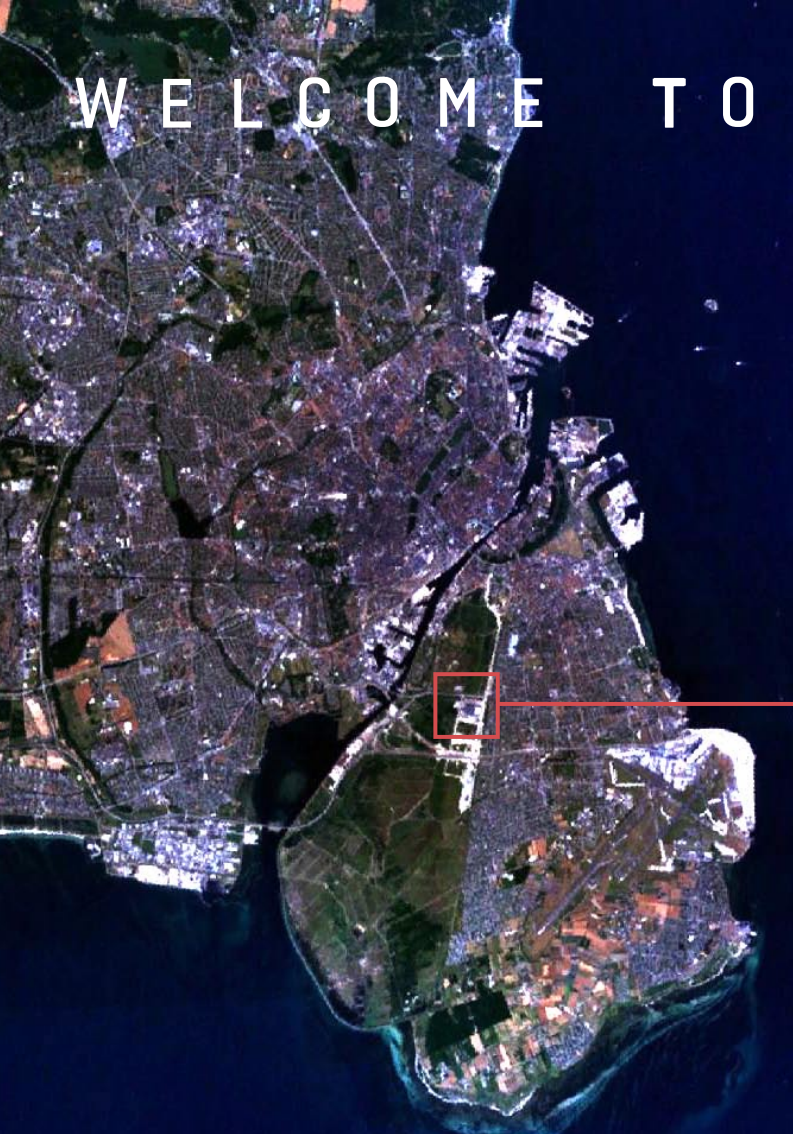

## WELCOME TO THE BELLONA ROOM AT COP 15

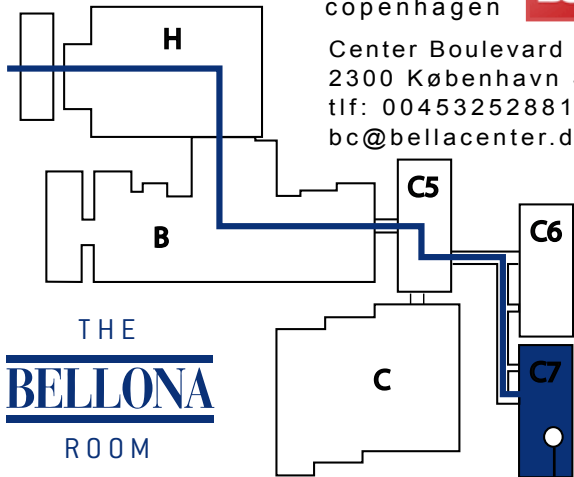



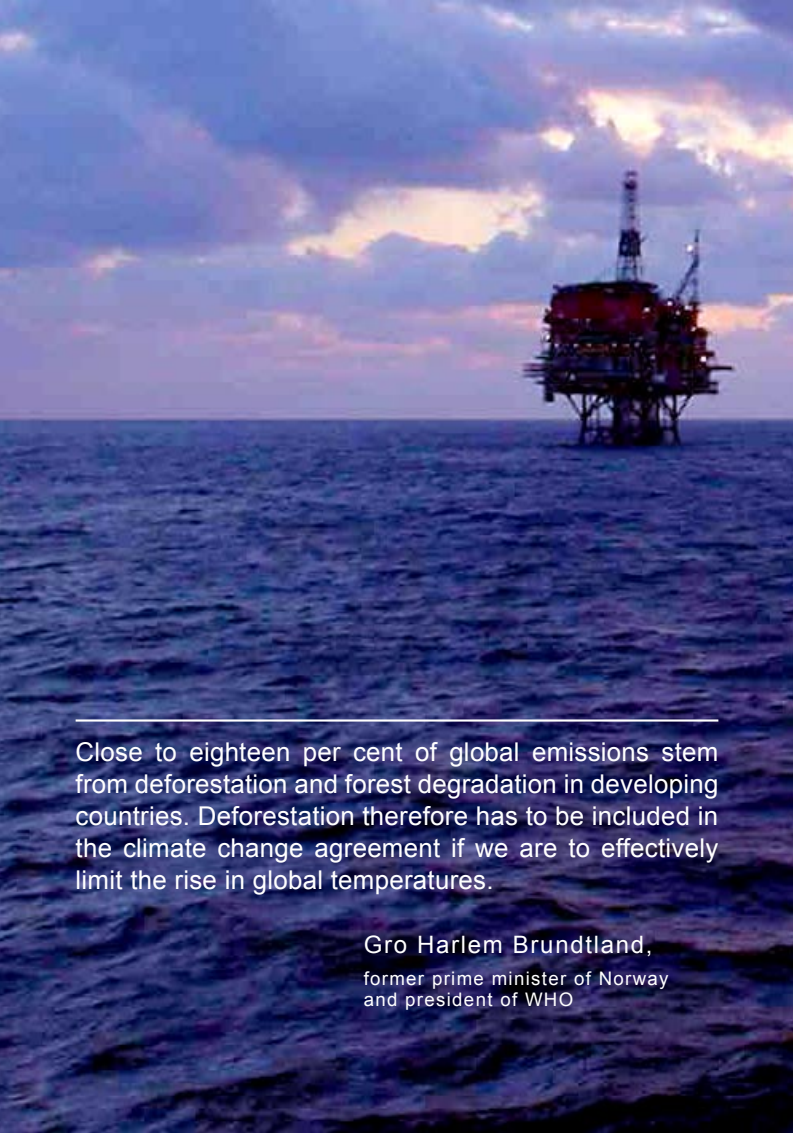
